Statute of the organization

Yooy

Article 1

We life bearing (istočnici) from the east and the west have gathered to develop, encourage and improve economic activity in completely organic spirit and with that contribute to all the people of the world in the fight against climate change and improve healthy way of life with sustainable innovative principles and methods.

The subject of work

Article 2

Gathering and studying of old writings primarily connected to agriculture, botany, geology with reference to endemic species and studying, preservation and their possible use while not disrupting natural flows and considering today's state – react according to the priority of protection.

With innovative procedures take advantage of information, create new materials and knowledge to create new products while in accordance with nature and organic principles of market production and thereby help the population in passive and rural areas.

Article 3

The public of work

Projects are public. All relevant works will be put up for public inspection and in accordance to copyright regulations and other similar rights with the written approval of the author and the senate.

As well as putting it on display and displaying financial income, donated income, expenditure is public.

Article 4

Legal status

We are a non-profit organization which all income invests in development in accordance to program and goals, regulations and internal acts.

Article 5

Property

All property gained during the organization's existence will be considered organization's property and ownership of all members who are obligated to manage it in a prescribed manner. Management and inventory of property will be done once a year.

Article 6

Independence

We are an independent organization managed by its members through its organs in the entire territory of the world. With the development and expansion there will be multiple regional centers which will have its own management bodies.

Article 7

Stamp and headquarters

Stamp that is, emblem, will be comprised of a shield with a cross, glasses and our logo with a laurel leaf.

Headquarters will forever be in Nish and the senate won't be able to change it. From the city of birth of Constantine the Great, Serbia, the whole Helm Peninsula we strive to enter each home in the world.

Article 8

Choice

Everyone can be our member or volunteer which is decided by a rule book. Active members have the right to vote. Permanently employed member can become our member at the suggestion of 10 other active members with the approval of their territorial center.

A lifetime employed member can become a distinguished member after the territorial center's recommendation and territorial parliament voting.

Membership fee on an annual basis is regulated for all members by the rule book and is paid at the latest until October 1st of this year.

Active members are not required to pay a membership fee as neither are volunteers. You become an active member by the certificate of attendance “lighting a fire”. Either by video or photo proof of single handedly lighting a fire from above and proof of the first pyrolysis.

Article 9

Electoral assembly (senate)

Is convened every 3rd year on November 16th. The first electoral assembly will have a mandate of 3 + 3 years. The second will be held on November 16th 2030 in Nis, the city where Constantine the Great was born and lived more than 1700 years ago.

Article 10

Composition of the department

With general work programs in accordance with needs and possibilities and interest and profitability will develop a sphere of work: research, systemization, all-inclusive work reports.

Article 11

Awards

Work, practical work, research and commitment, standing out in production, selling, new ideas is rewarded with additional bonuses and awards defined by a special agreement. The most successful individuals awards will be awarded at the prize assemblies.

Article 12

Library

Acquires, saves, processes and puts the most important cognitions linked to certain spheres of work to use.

Article 13

Research center

According to the possibilities, the formation of the center is mandatory. The goal is formation of independent national laboratories as independent legal entities. For the protection of consumers, according to all criteria, the existence of our mini laboratories is mandatory.

Article 14

Service

For financial, legal and other affairs, as well as the manager of the service for coordination in accordance with the regulations and in accordance with needs.

Article 15

Authorities

1. Assembly (all members)
2. The presidency (also the executive board) makes decisions; equally and evenly
President of the presidency = Executive president
3. The secretary – multiple units in second stage when they develop – every region will have its own assembly where it will form the senate as the upper house and will be delegated from territory of the presidency
Certain number of members (senators)
4. President

Article 16

Finances

Funds are provided from own income, donors and foundation and according to the law. For certain donations and foundations it is required to make a decision about accepting according to the regulations.

Article 17

Conflict of interest and plagiarism

New works and dishonorable intentions must be viewed with care. Principles of behavior, ethics and business code will be regulated by the rulebook. Commissions will be in charge of following irregularities.

Article 18

Help

All employees have the right to help that is based on principles of humanity and justice.

Article 19

Responsibility

Every member is responsible and obligated to follow the law, principles and provisions of this institute and rulebook. Commissions are obliged to carry out control and investigate about any irregularities with the possibility of exclusion from the organization.

Article 20

Statute can be changed, improved and aligned depending on the needs of fast changes that are happening today and in accordance with the article 6. The organization has the right, by the law, to register social firms.
